**PRODUCT DESCRIPTION:** Permatter® is manufactured from Nitinol. This appliance is meticulously manufactured based on recent impressions of the patient's teeth. Permatter® is intended for use as a lingual retainer wire for retaining teeth positions after orthodontic treatment.

**INTENDED USE:** Permatter<sup>®</sup> is intended for use by orthodontists, dentists, and dental laboratories. U.S. Federal law restricts this device to sale by or on the order of a dental professional.

INDICATIONS FOR USE: Permatter® is designed to be worn by the patient as directed by the treating dental professional. The duration of wear should be determined by a dental professional.

LIMITATIONS: Permatter® should not be used in patients with active periodontal disease, active malocclusion retention (e.g., deep bite with insufficient space for bonding the retainer, less than 0.5 mm space). Additionally, it is not recommended for individuals with habits such as nail or lip biting.

## **PRECAUTIONS**

- This product is non-sterile.
- Rubbing of parts against tissue may cause sores.
- Hard, crunchy or sticky foods may cause damage to the appliance; additional information of wearing a fixed retainer should be explained to the patient in detail.
- Incorrect biting may lead to improper functioning of the device.
- Accidental swallowing or aspiration of parts may result in harm.

#### **INSTRUCTION FOR USE**

## • Unpacking and Cleaning:

Remove the retainer from its packaging and clean it according to office protocols.

#### Initial Evaluation:

Assess the fit of the retainer and the tray/jig on the model provided, whether it's the physical model sent or a 3D printed model from digital data.

## • Testing Fit:

Remove the retainer with the transfer tray/jig from the model and rinse it under water. Dry it carefully with air flow to avoid displacement.

Insert the retainer with the transfer tray/jig into the patient's mouth to test the fitting. If satisfactory, proceed to the next step. If not, please contact the provider or Permatter® for evaluation. It's crucial to re-test the fit on the delivered model to ensure accuracy. If it fits on the model but not in the patient, refrain from bonding the retainer as the patient's situation might have changed, potentially leading to tooth movement and related consequences.

## • Pre-Bonding Preparation:

Remove the retainer and transfer tray/jig from the patient's mouth and thoroughly clean the lingual surface and surrounding area of the teeth. It's recommended to scale and polish the anterior lingual side of the teeth to remove calculus and any obstacles for proper bonding, finally rinse and dry.

#### • Etching:

Acid etch the enamel for 30 seconds. Rinse and dry thoroughly.

## • Placement and Securing:

Place the retainer with the transfer tray/jig back and ensure proper fit to the lingual surface of the teeth.

## Bonding:



**NOTE:** According to the debonding tests results, Permatter<sup>®</sup> shows better results with the usage of "3M - Transbond™ LR Light Cure Adhesive".



**IMPORTANT:** When seating the Permatter<sup>®</sup>, ensure the wire is held securely before removing the tray. Failure to do so may result in unsuccessful placement of the wire.

Apply prime/bonding agent only to the lingual surface of the canines. Shape the fluid material to cover ends of the retainer adequately with an instrument. Light cure the composite material on the distal ends of the lingual retainer. Wait at least 30 seconds for the next step.

## • Tray/Jig Removal:

Carefully remove the transfer tray/jig.

## Bonding Remaining Teeth:

Apply a prime/bonding agent to the remaining non-bonded enamel. Shape the fluid material to cover the retainer adequately with an instrument to cover the lingual retainer.

## • Finalizing Bonding:

Cure the remaining enamel after bonding.

## Post-Bonding Clean-Up:

Thoroughly clean the patient's teeth to complete the process.



**IMPORTANT:** Advise patients to not eat/drink anything for at least 3 hours.



**IMPORTANT:** If Permatter<sup>®</sup> is used on the upper 1-1 or 2-2, likewise for the deep bite case, it is recommended that a clear thermoplastic retainer be incorporated with the Permatter<sup>®</sup> wire for best results.

**WARRANTY:** This product comes with a warranty of 36 months.
